Medisec FactSheet Garda Vetting in General Practice

The National Vetting Bureau (Children and Vulnerable Persons) Acts 2012 to 2016 provide a statutory basis for the vetting of persons carrying out what is described as "relevant work" with children or vulnerable persons. The Acts say that a "relevant organisation" shall not permit any person to undertake relevant work or activities on behalf of the organisation, unless the organisation receives a vetting disclosure from the National Vetting Bureau in respect of that person.....


