Dear Members and Friends,

While the start of 2021 has been challenging, we sincerely hope brighter times are afoot. We are so impressed by the resilience shown by GP teams across the country and the enthusiasm to play the most important role in the battle against COVID 19 by vaccinating patients. By the time of reading this, we hope that you have all been vaccinated for your own protection and safety.

As recently advised, an indemnity from the State is in place for GPs and nurses administering the COVID vaccine and further information can be found in our guidance documents **here** and **here**.

Please remember that for the State Indemnity to apply, it is important that you complete the relevant training specified by the HSE and follow their guidelines concerning the storage, handling, use and administration of the vaccines. The State Indemnity will not cover GPs or practice nurses in respect of their own negligence: e.g wrong site administration, not following storage or handling instructions, not observing patients for time indicated following vaccination. This will fall to the GPs or practice nurses' own indemnifier.

Medisec has confirmed that our members can participate in the HSE run vaccination programme and will have professional indemnity insurance in place per their existing policy terms and conditions. Medisec members will also be covered for any IMC complaint that arises, as this is also not covered by the State Indemnity. As always, we are on hand for any advice you may need in relation to indemnity.

# Off-Site COVID-19 Vaccination Clinic

Medisec has received many queries regarding the suitability of practice car parks, halls or other off-site venues for holding vaccination clinics, bearing in mind both the need to socially distance patients, and to accommodate patients who may have reduced mobility, as well as being aware of the importance of efficient vaccination delivery in all age cohorts.

Please note that the HSE has laid down clear guidelines in the operational document

'Clinical Guidance for COVID-19 Vaccination' which is available as a live document online **here:**

While the HSE standards do not preclude the use of certain off site venues, their standards and guidelines must be adhered to at all times in order to avail of State Indemnity which excludes acts of negligence by the doctor.

# **High Court Directions: Enduring** Powers of Attorney (EPAs) & **Wardship Applications**

The President of the High Court issued new practice directions that came into effect in October and November 2020 relevant to doctors preparing medical affidavits/ certificates/ reports in relation to the registration of an Enduring Power of Attorney and in Wardship Proceedings.

While the requirements for what must be included in the above medical documents are similar in respect of both processes, there are subtle differences and we have set out the full list of requirements from each practice direction so that you can clearly see the specifics of what must be included, depending on the application.

# Clarification on Nurse Coverage

The professional indemnity cover arranged by Medisec extends to practice nurses if the nurse is employed directly by the sole trader GP. Our underwriters, Allianz require the name of the practice nurse to be added to the GP policy in this case.

Where a partnership, company or other legal entity is the nurse's employer, a practice malpractice policy is available. It provides cover for the vicarious liability of the entity in respect of the malpractice of employees of a GP practice including practice nurses. All GPs working in the practice require their own professional indemnity, as per IMC guidelines.
