- Cover for alleged discrimination under the Equal Status Acts

This is a "Claims-Made" insurance policy. This means that the policy responds to claims made during the policy period for incidents arising from the provision of professional services on or subsequent to a retroactive date. Cancelling or allowing the policy to lapse without purchasing an Extended Reporting Period from an insurer (tail cover) may mean no coverage is in place for such claims.
